### Available MASSIVE Services (Please select on page one above):

**Medicare Set-Aside with NMCP** - The MSA allocation determines what medical costs Medicare would pay for, if it was the primary payer for the sued-for injuries. The NMCP portion includes medical costs that Medicare generally does not pay for (such as most over-the-counter medication). We offer the combination of the MSA and NCMP at no additional charge to make up for this omission; however, we can also create an MSA without Non-Medicare expenses. Fee: \$3,000

**Non-Medicare Cost Projection (NMCP)** - This projection determines what medical costs will be missed by a MSA. It is used as a supplement to a MSA, as it only considers items that Medicare generally does not pay. *This will not be a complete projection for someone who is not covered by Medicare.* Fee: \$1,500

- All cost projections include non-medical costs such as home and vehicle modification, *professional* household services like gardening, transportation costs, and more. Please check here if you do not want these services included in the Cost Projection report.

**Full Medical Cost Projection (Non-Itemized)** - This projection determines all future medical costs but, does not separate between Medicare and Non-Medicare. This is the best option to project all future medicals for a person not covered by Medicare. Fee: \$2,000

**MSA Submission to CMS** - We will only submit the MSA to the Centers for Medicare & Medicaid Services (CMS) with your permission. Please note that CMS will likely not review Liability MSAs. Please allow 4-6 weeks for CMS to process and respond. Fee: \$500
